## California Highway Patrol (CHP)

For over three years, Auriga has been performing Independent Verification and Validation (IV&V) and Risk Assessment Services for the California Highway Patrol Enhanced Radio System (CHPERS) project.

The scope of this 5-to-7 year project, valued at \$492 Million, is to replace and enhance the radio system used throughout the State of California by the CHP.
